<u>Directive issued by the power vested under Section 13(c),13(h) and 13(p) of the Securities and Exchange Commission of Sri Lanka Act No. 36 of 1987 (as amended)</u>

The Securities and Exchange Commission of Sri Lanka (SEC) having carried out a preliminary inquiry into the conduct of Touchwood Investments PLC, has decided to commence a fully fledged investigation in to the business affairs of the said Company.

In view of the commencement of investigation under the Securities and Exchange Commission Act No. 36 of 1987 (as amended) the Commission has decided to issue the following directive;

The Colombo Stock Exchange is hereby directed to suspend trading of listed securities of Touchwood Investments PLC with immediate effect for three market days commencing from 10th September 2013.
